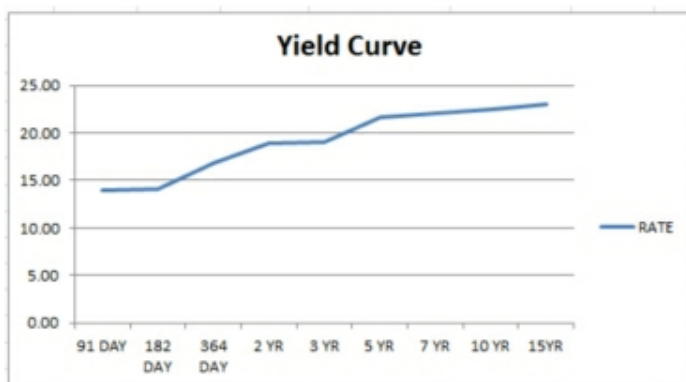

Comments



Trading as at 3rd February 2021 saw the market experienced a decreased in turnover by 22.26% as it recorded over GHS 617 million worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 73.27% of total trades while that of bills and notes were 20.59% and 6.14% respectively.

The top 5 traded instruments were the June 25 5YR, May 21 91 DAY COCOA, February 23 5YR, September 23 3YR and January 23 3YR in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 58% of the total volume of trades.
