Today's trading session ended with a 17.78 points increase in the Ghana Stock Exchange's Composite Index (GSE-CI). The market capitalization also increased by GH¢ 188.08 to GH¢ 53,461.32. The year-to-date return is recorded at -17.85% .

A total volume of 5,191,533.00 shares valued at GH¢46,468,748.50 exchanged hands on the bourse. The most traded equity for today was UNIL whose trade accounted for 95.59% of the total shares traded and 98.36% of the total value of shares traded.

There were two price changes as the market recorded two gainers for today. Total Ghana was the day's biggest gainer as the stock price appreciated by 9.69% to close the market at GHS 2.83 per share.

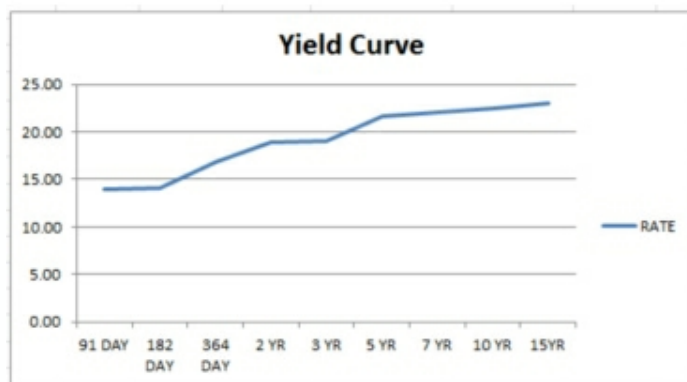

Comments

Trading as at 10th December 2020 saw the market experienced an increased in turnover by 0.47% as it recorded over GHS 744million worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 81.61% of total trades while that of bills and notes were 11.04% and 7.35% respectively.

The top 5 traded instruments were the November 26 10YR, January 23 3YR, February 21 182 DAY, February 23 5YR and February 21 2YR in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 76% of the total volume of trades.
