Today's trading session ended with a 1.73 points increase in the Ghana Stock Exchange's Composite Index (GSE-CI). The market capitalization also increased by GH¢18.10 to GH¢ 54,690.91. The year-to-date return is recorded at 1.42%.

A total volume of 47,710 shares valued at GH¢87,652.62 exchanged hands on the bourse. The most traded equity for today was CAL whose trade accounted for 35.82% of the total shares traded and 13.45% of the total value of shares traded.

There were two price changes as the market recorded two gainers for today. SOGEGH was the day's biggest gainer as the stock price appreciated by 3.13% to close the market at GHS 0.66 per share.

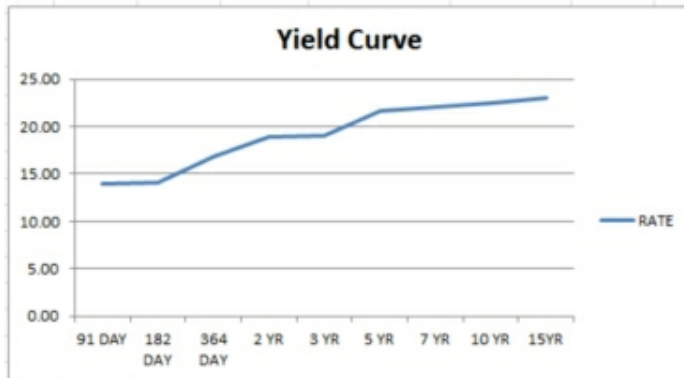

Trading as at 12th January 2021 saw the market experienced an increased in turnover by 23.75% as it recorded over GHS 939 million worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 83.30% of total trades while that of bills and notes were 5.05% and 11.65% respectively.

The top 5 traded instruments were the November 27 7YR, December 23 3YR, May 23 3YR, January 23 2YR and March 23 3YR in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 52% of the total volume of trades.
