Today's trading session ended with a 2.94 points decreased in the Ghana Stock Exchange's Composite Index (GSE-CI). The market capitalization also decreased by GH ϕ 30.76 to GH ϕ 53,092.52 .The year-to-date return is recorded at -19.40%.

A total volume of 776,877.00 shares valued GH¢696,267.70 exchanged hands on the bourse. The most traded equity for today was GGBL whose trade accounted for 97.76% of the total shares traded and 98.17% of the total value of shares traded.


There was one price change as the market recorded one loser for today. GGBL was the day's biggest loser as the stock price declined by 10% to close the market at GHS 0.90 per share..

Comments

Trading as at 24th November 2020 saw the market experienced a increased in turnover by 14.96% as it recorded over GHS 403million worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 83.76% of total trades while that of bills and notes were 9.90% and 6.34% respectively.

The top 5 traded instruments were the June 25 5YR, November 22 5YR, January 23 3YR, May 28 10YR and May 21 182 DAY COCOA in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 65.59% of the total volume of trades.

The forex bureau market increase its forex rates with regards to the dollar, the euro and the pound sterling by 0.78%, 0.71% and 1.11% respectively for today.
