Today's trading session ended with a 21.84 points increase in the Ghana Stock Exchange's Composite Index (GSE-CI). The market capitalization also increased by GH¢228.62 to GH¢ 55,301.66. The year-to-date return is recorded at 4.23%

A total of 70,203 shares valued at GH¢ 65,812.59 exchanged hands on the bourse. The most traded equity for today was MTNGH whose trade accounted for 80.08% of the total shares traded and 58.08% of the total value of shares traded

There were two price changes as the market recorded two gainers for today. SCB was the day's biggest gainer as the stock appreciated by 10.00% to close the market at GHS 18.15 per share

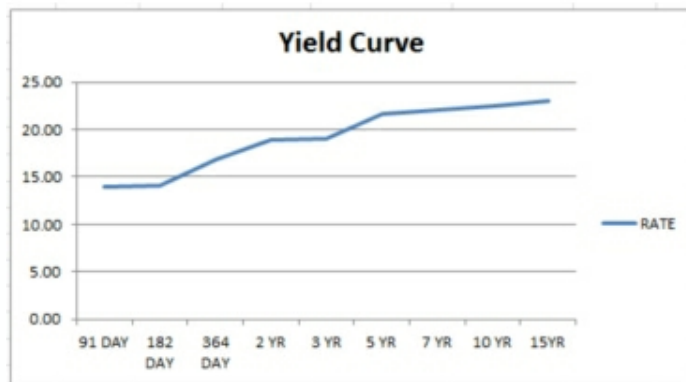

### Comments



Trading as at 25th January 2021 saw the market experienced an increased in turnover by 4.36% as it recorded over GHS 756 million worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 83.55% of total trades while that of bills and notes were 13.59% and 2.86% respectively.

The top 5 traded instruments were the January 27 6YR, March 32 15YR, February 23 5YR, July 21 DAY COCOA and January 22 DAY COCOA in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 70% of the total volume of trades.
