

Comments

Trading as at 27th January 2021 saw the market experienced an increased in turnover by 136% as it recorded over GHS 1.1 billion worth of bonds, notes and bills traded. The long term dated instruments dominated the trading activities as compared to the short and the medium term securities as trades in bonds accounted for 83.97% of total trades while that of bills and notes were 4.00% and 12.03% respectively

The top 5 traded instruments were the September 23 3YR, March 32 15YR, January 27 6YR, November 26 15YR and December 23 3YR in that order as indicated in the table above. In all, the top 5 traded instruments accounted for 61% of the total volume of trades.
